

Getting Started

SERFF is the most cost-effective and efficient way to submit rates and form filings to the states and jurisdictions. Outside of training or the tutorial you will only need an Internet Browser and Adobe Acrobat or a PDF producer to submit filings with SERFF. There are no licensing fees to use SERFF.

To start the licensing process, complete the following pages and send to **serffmktg@naic.org**. Once the SERFF team receives your completed paperwork, we will contact you to begin the next steps.

In addition to the implementation paperwork, new licensees will need to answer the following questions:

1. Will you attend NAIC SERFF Training or prefer the On-Demand Tutorial?

2. SERFF now provides a solution that will allow the NAIC to host the filings.

There are a number of benefits of having the NAIC host your company's filings. Data Hosting will provide the retention of all SERFF filings, including those that have been marked for deletion by states using State Data Retention. It is important to note that if your company does not choose to be hosted by the NAIC, your data will be subject to the State Data Retention requirements and as such, may be deleted based on state requirements.

3. Will you need to pay your state filing fees electronically using Electronic Funds Transfer(EFT)? Yes____No____

- Companies have the option to use EFT for payment of state filing fees. Nearly half of all states have mandated that their state filing fees be paid via SERFF EFT. What that means is, if you do business in these states and pay a filing fee, you will be required to license to use EFT via SERFF to pay your state filing fees. Please note that EFT implementation is done by your Bank Account Manager once your SERFF implementation is complete. You will designate a Bank Account Manager on the Payment Role Authorization page.
- 4. NAIC Transaction Fees are paid upon submission utilizing EFT. If you have configured EFT for state filing fees, your transaction fees will also be paid at time of submission. If you do not have state filing fees, we will enable your instance for transaction fees to be paid via Credit Card.

Roles and Descriptions					
User Admin Request User:	Allows the user to request new users, update current user roles, deactivate users on behalf of their Account, and execute and review User Admin reports.				
Industry Configuration Manager:	The Industry Configuration Manager: Creates/Edits Statuses (company) Creates/Edits New Companies & Contacts. The Industry Configuration Manager DOES NOT automatically have a filing role. You must assign either Industry Filer or Industry Filing Manager role as well. At least one person must have this role.				
Bank Account Manager:	Allows the user to add, edit and deactivate bank accounts on their SERFF account and associate entities to bank account(s).				
Industry Filers:	Users who can create, submit, and modify filings that they have Authored.				
Industry Filing Managers:	Users who can modify any filing in the instance, even those they have not authored. Filing Managers are automatically Industry Filers and do not need this role assigned separately. Assign this role only to those who need to have access to all filings.				
Industry Record Retention:	Users with access to the Record Retention tab, indicating filings set for destruction by the state. At least one person must have this role.				
Read Only:	Users who can only view filings in the instance.				
EFT User:	Allows user to submit transactions with EFT Payments				
Payment Reports:	Allows the user to run EFT or Credit Card payment Reports.
