The System for Electronic Rate and Form Filing (SERFF) is a web-based application that is governed by the NAIC. More than 3,900 insurers use SERFF to streamline state-by-state rate and form filing processes for market entry. By filing electronically, insurers save administrative costs and obtain regulatory approvals faster.

State filings submitted on the NAIC server become the property of that state's Department of Insurance. Such filings are subject to each state's data retention policies, placing insurers at risk of losing their data at any time.

The NAIC selected SkiiTech as its preferred data hosting provider for insurers requiring redundant and long-term storage of their electronic and paper rate and regulatory form filings.

- Data center access, power, temperature, and humidity level are monitored 24 hours a day by an electronic monitoring system.
- Facility operates redundant electrical power, temperature control and HVAC, fire suppression, and physical security.
- System access is controlled by password authentication and all data is encrypted using Secure Socket Layer (SSL). User passwords are hashed with a non-reversible SHA-2 algorithm. In addition, operations, traffic, performance and data flow are monitored 24x7x365.
