




### **Phase 2 - Reporting Capabilities**



- Currently in Sprint 4 of 8
- Foundation SERFF data to Enterprise Data Warehouse (EDW)
  - 30% development complete
- Tableau Dashboards
  - Data modeling 75% complete
  - First dashboard in development
    - High-level Metrics for Overview Information
- Users will log into NAIC's Tableau site during transition.





Want to make sure that when performing a search on a large number of filings, we'd like the ones that have been viewed to change color so we don't repeatedly click on the same filing. This is going to make searching filings so much easier!

Seeming lack of changes to certain pain points like objections and objection letter creation



### What confuses or worries you?

accuracy of legacy data migration?

Nothing confusing so far. Concerns about how things will work and the impacts on state review and reporting operations while things are split by product line temporarily during the implementation phases.

We have users that use P&C instance and LDH instance to do their work; what happens when one instance is changed to the new and one instance changes later?

Losing a capability I find beneficial today.

Making sure all trouble errors are improved upon---including errors we experience re: trade secret.

Just how things will change to our normal work environment. For instance we have 3 intake people, most instances dont have that from what I've herd

Will the screens in SERFF change a lot?

Will the calculations in the Rate/Rule Schedule tab be updated for multiple companies, for P&C.
