Demo Q&A pt. 1

These are the questions that were not answered during the meeting

- Q: Can reviewers just create a compliance report rather than compliance issues/add attachments to compliance issues or reports?
 - A: We are building the compliance workflow to support AI, automation, and reporting capabilities eventually. We will need to evaluate how these requests will interact with these features.
- Q: Will the individual that is assigned the task receive email notifications that they have a task assigned?
 - A: Yes, if they have email notifications enabled.
- Q: Will the EFT report be the same?
 - A: We will have a version of the EFT report and you will be able to customize it.
- Q: Will the dashboard customizations save after they are set?
 - A: Yes, they will save.
- Q: Will it be possible for all users to create filing labels and/or quick text, rather than just administrative type users?
 - A: We will put some settings in place so you can control who can create filing labels and quick text.
- Q: Do we have to re-create our compliance issue text?
 - A: No, we will be migrating your current quick text.
- Q: Will the SERFF Retention Tab and process change?
 - A: We haven't dug into that workflow yet since the Compact does not use the data retention feature.
- Q: Who is an industry task assigned to?
 - A: By default, the task will be assigned to the filing contact, which is now a SERFF user. However, we are working through options for companies that handle their work assignment differently.

Demo Q&A pt. 2

These are the questions that were not answered during the meeting

- Q: Does the dashboard view let you see multiple instances on one dashboard?
 - A: Right now, it just shows one instance at a time. We understand some users would like to see data across instances, so we are working through those requirements.
- Q: Can we add tables to filing description?
 - A: I don't believe tables are included in the richtext formatting we have implemented. If anyone has examples of table content they would add to the filing description, please send them to us.
- Q: If a state public records law requires that internal notes be made public, can a state set that option for a filing?
 - A: Yes, that will be an option.
- Q: When will the reporting capabilities be available for P&C?
 - A: Tableau Dashboards are available now. The reporting in the new system will be available when P&C goes live.
- Q: Do you have more information about upcoming training?
 - A: We are still designing the details of our training strategy.
- Q: Will everyone be going live at the same time, or will it be staggered?
 - A: We will be rolling out by business type (Compact, Life, P&C, Health), so everyone in that business type will go live at the same time.

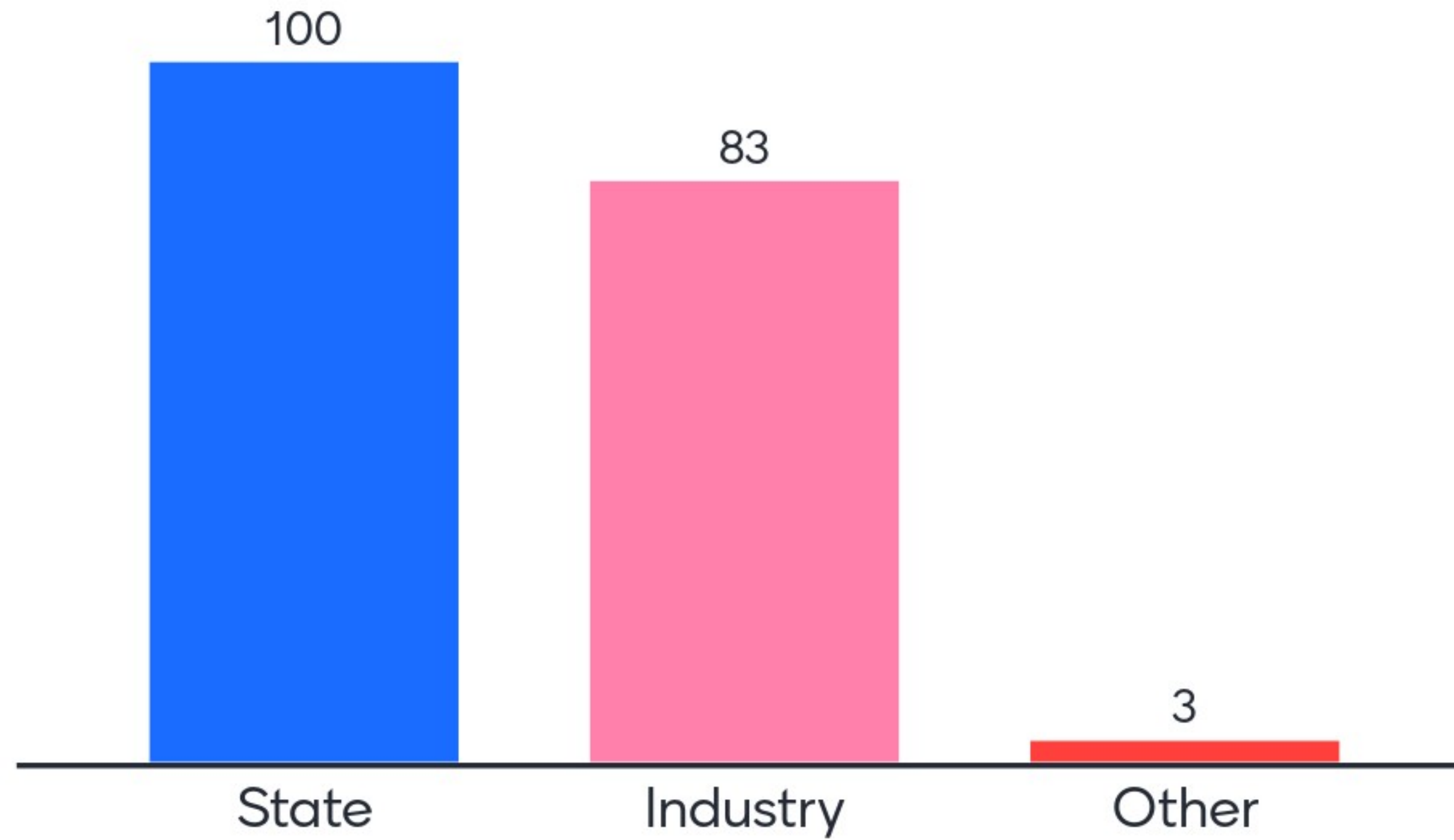

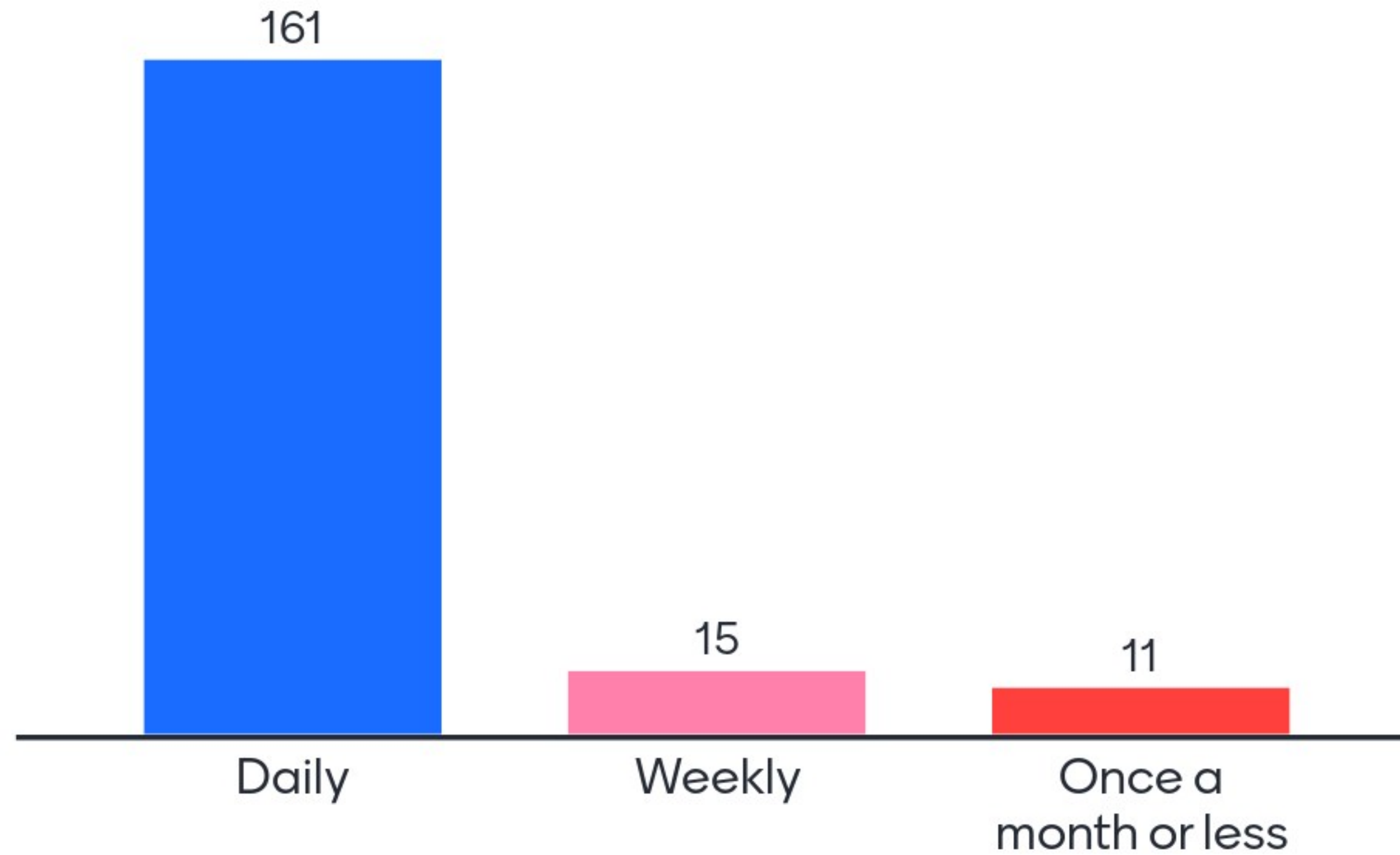
